## NORFOLK COUNTY COUNCIL (BURGH AND TUTTINGTON) TEMPORARY TRAFFIC RESTRICTION ORDER 2020 ROAD TRAFFIC REGULATION ACT, 1984 SECTION 14(1)

ORDER prohibiting the use by vehicles of Aylsham Road from its junction with The Green for a distance of 100 metres eastwards in the PARISH OF BURGH AND TUTTINGTON

- Save as provided in Article 2 of this Order and whereas the Norfolk County Council as Traffic Authority for the Administrative County of Norfolk is satisfied that:-
  - (i) works to renew BT cables are required at Aylsham Road from its junction with The Green for a distance of 100 metres eastwards in the PARISH OF BURGH AND TUTTINGTON (hereinafter referred to as the said road) and:
  - (ii) that in consequence traffic over the said road should be prohibited with effect between 08:00 and 17:00 hours from 3<sup>rd</sup> December 2020 to 4<sup>th</sup> December 2020 for the duration of the works expected to be about 2 days within the period.
- 2. Nothing in Article 1 of this Order shall make it unlawful for a vehicle which requires access, to proceed to a final destination situated within the length of road specified in Article 1 of this Order.
- 3. This Order has a maximum duration of 18 months and will be revoked upon completion of the works. Where exceptional circumstances are encountered during the performance of the works specified in this Order the operational period of this Order may become extended to allow completion of the works after obtaining consent of the Secretary of State.

NOW THEREFORE the Norfolk County Council DO HEREBY ORDER, that with effect between 08:00 and 17:00 hours from 3<sup>rd</sup> December 2020 to 4<sup>th</sup> December 2020 for the duration of the works the said road SHALL NOT BE USED by any class of vehicle.

NORFOLK COUNTY COUNCIL proposes to make a Temporary Traffic Order affecting Aylsham Road from its junction with The Green for a distance of 100 metres eastwards in the PARISH OF BURGH AND TUTTINGTON because of works to renew BT cables.

The road will be temporarily closed (except for access) between 08:00 and 17:00 hours from 3<sup>rd</sup> December 2020 to 4<sup>th</sup> December 2020 for the duration of the works, expected to be 2 days within the period.

Alternative route is via: Aylsham Road, Tuttington Road, A140 Aylsham Bypass, B1145 Banningham Road/ North Walsham Road, Tuttington Road, Banningham Road, Aylsham Road (Colby, Burgh and Tuttington, Aylsham).

(If necessary the restriction could run for a maximum period of 18 months from the date of the Order).

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.

In the event of the start date being delayed the new start date will be displayed on site in advance.


